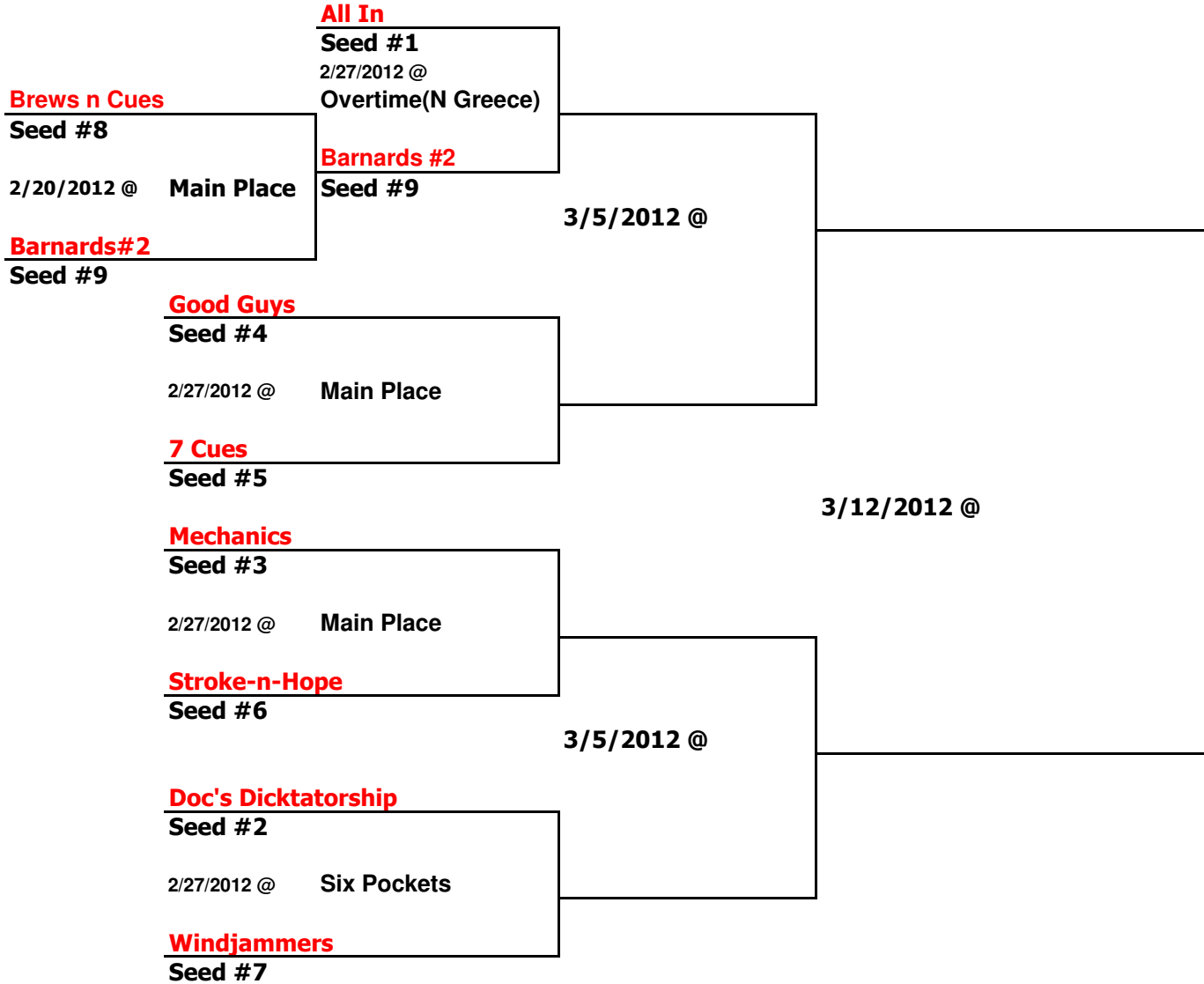
- 1) No subs allowed.
